Maximum size of papers: 10 pages, incl. formulas, tables, figures and referenced literature; line spacing – 1,5.

Page Setup: Top – 2,5; Bottom – 2,5; Left – 2,5; Right – 2,5; Paper Size – A4.

Title: Font: Times New Roman; Size: 14 pt; Font Style: Bold; Alignment: Centered; Effects: Capital letters; (followed by one blank line).

Academic position, degree, given name and family name of the author (coauthors): Font: Times New Roman; Size: 12 pt; Font Style: Bold & Italic; Alignment: Centered.

Affiliation: Font: Times New Roman; Size: 12 pt; Font Style: Bold & Italic; Alignment: Centered; (followed by 1 blank line).

Body of paper: Font: Times New Roman; Size: 12 pt; Justified; Spacing: 1,5 lines.

Tables: Arabic numbering above the table, centered title, Font Style: Bold; (leaving 1 blank line before and after).

Figure: Arabic numbering centered title below the figure, Font Style: Bold; (leaving 1 blank line before and after).

Referencing: Footnote, Footnote Text – 10 pt; Number format: 1,2,3 ...
